**THE COUNTY OF DEVON (TEMPORARY RESTRICTION) (BUDLEIGH SALTERTON
CARNIVAL, BUDLEIGH SALTERTON) ORDER 2018**

TEMPORARY PROHIBITION OF THROUGH TRAFFIC & PARKING

NOTICE is hereby given that Devon County Council has made the above titled order.

On **SATURDAY 29 SEPTEMBER 2018**
for a maximum of 3 days

Anticipated Finish **SATURDAY 29 SEPTEMBER 2018**

No person shall cause or permit any vehicle to proceed on the sections of Affected Roads.

Roads affected - Between the hours of **16:00** and **22:00**
**UPPER STONEBOROUGH LANE BETWEEN ITS JUNCTION WITH LEAS ROAD AND EAST
BUDLEIGH ROAD. EAST BUDLEIGH ROAD BETWEEN BRIDGE ROAD AND UPPER
STONEBOROUGH LANE**

The alternative, signed, route for vehicles will be via - EAST BUDLEIGH ROAD, BRIDGE ROAD,
COPP HILL LANE, GREENWAY LANE AND LEAS ROAD.

Roads affected – Between the hours of **19.00** and **21.00**
**EAST BUDLEIGH ROAD, COASTGUARD ROAD, MARINE PARADE, FORE STREET, HIGH
STREET, STATION ROAD, WESTHILL, BETWEEN STATION ROAD AND LITTLE KNOWLE ,
BUDLEIGH SALTERTON**

The alternative, signed, route for vehicles will be via - EAST BUDLEIGH ROAD, B3178 KNOWLE
VILLAGE, EXMOUTH ROAD (B3178) AND WEST HILL.

No person shall cause or permit any vehicle to wait on the sections of Affected Roads.

Roads affected – Between the hours of **17.00** and **22.00**

**FORE STREET AND HIGH STREET BETWEEN MACKEREL SQUARE AND STATION ROAD
STATION ROAD BETWEEN WEST HILL AND WESTFIELD ROAD
UPPER STONEBOROUGH LANE BETWEEN LEAS ROAD AND EAST BUDLEIGH ROAD**
